“Subjects, Tenants, Christians, and Neighbors: South Carolina in North Carolina’s Tuscarora War”

David La Vere, UNC Wilmington

David La Vere is a Professor of History at UNC Wilmington, where he has taught for more than two decades. He is the author of seven books on American Indian History, most recently *The Tuscarora War: Indians, Settlers, and the Fight for the Carolina Colonies* (UNC Press, 2013). His teaching and research currently focuses on Southeastern Indians, particularly those of the Carolinas.
